The certificated AT&T Companies, together with AT&T wireless providers, including AT&T Corp., Teleport Communications America, LLC, New Cingular Wireless PCS, LLC, d/b/a AT&T Mobility, and Cricket Wireless, LLC (collectively, the “AT&T Companies”) submit these Comments in response to the Request for Comments issued April 8, 2016 (the “Request”). The Request invites comments on whether the current mandate to file both paper and electronic filings to the PSC be revised to eliminate the requirement to file paper copies. The PSC also invited comments about other options that may exist to simplify filing and service requirements.

**COMMENTS**

The AT&T Companies have reviewed CenturyLink’s Comments, filed on May 12, 2016 and support all of the recommendations of CenturyLink. They represent best practices in electronic filing that the AT&T Companies have seen adopted in other jurisdictions. They would reduce filing times (the AT&T Companies usually have to allow an extra day for their Utah

filings currently to accommodate overnight mail delivery of paper copies), reduce the effort needed to prepare and produce paper filings, and save on the unnecessary use of paper.

The AT&T Companies appreciate the opportunity to provide these comments.


