**QUESTAR GAS COMPANY'S  
COMMENTS**

Questar Gas Company (Questar Gas or Company) respectfully submits these comments in response to the Request for Comments issued on April 8, 2016 (the Request). The Request invites comments regarding potential amendments to R746-100-3 to eliminate the requirement to file paper copies.

**Comments**

Questar Gas supports amending R746-100-3 (the Rule) to eliminate the requirement to file paper copies. Questar Gas believes that electronic filing is the most efficient manner for filing and that eliminating paper copy requirements would significantly simplify the filing process.

Eliminating unnecessary paper copies will also minimize associated waste. The Utah Department of Environmental Quality noted that “the most effective way to reduce waste is to not create it in the first place.” “Recycling/Waste Reduction/Reuse Program.” *Utah DEQ:*

*Programs: N.P., nd. Web. 14 May 2016.* Eliminating paper copy requirements would effectively reduce waste associated with paper copies of pleadings.

Questar Gas also notes that it currently provides courtesy paper copies of pleadings to individuals who request such copies and would continue to do so if the Rule were modified as described in the Request.

Questar Gas believes that the requirement to file paper copies of pleadings is unnecessary and amending R746-100-3 to eliminate the requirement to file paper copies is appropriate.
